AT A REGULAR MEETING OF THE LEWIS COUNTY FISCAL COURT, HELD AT THE COURTHOUSE IN VANCEBURG, KENTUCKY WITH THE HONORABLE CRAIG STANFIELD PRESIDING AND WITH THE FOLLOWING MAGISTRATES IN ATTENDANCE: ESQ. TERRI THOMAS, ESQ. DAVID IERY AND ESQ. WOODY UNDERWOOD, ESQ. CHUCK SWEARINGEN.

Johnny Bivens, Lewis County Sheriff, called the meeting to order.

Woody Underwood offered a prayer.

The Pledge of Allegiance was led by County Judge Executive Craig Stanfield.

### RESPONSE FROM THE PUBLIC

Colton McCane addressed the court about Ambulance Service District Board explaining the cost of the equipment and how much it would cost to run our own ambulance service. Debbie Boling addressed the Court about her husband Dudley death still waiting for answers for the mistake that were made asking Fiscal Court to pass the Ambulance Service District Board ordinance for a new ambulance service. Debbie has started a petition sheet for the betterment of Lewis County citizens. David Lancaster addressed the court about his concerns with the Ambulance Service that Lewis County have now with Portsmouth. Terri Thomas addressed the public that she is doing what is the best interest for the County.

On a motion made by Craig Stanfield with no seconded by the court the motion dies for Ordinance #22-03 Ambulance Service District Board.

Hannah has an ambulance service in Aberdeen Ohio she has been trying to get certificate for Kentucky which has been a problem. Debbie Boling asked Woody Underwood to explain

himself for not passing this Ambulance Service District Board Ordinance. Woody explain to Debbie that he thought there is still some confusion just because they wouldn't pass this ordinance does not mean that they are not in favor or that the county doesn't have other options. Woody, explain he has looked at some options he would explain later. Woody said that he would like to have all the fax before he decides. David Lancaster stated that we got to have this tax money out so we can collect it before looking at other options. Colton McCane said that the tax board would hold the ambulance service accountable for their actions. Chuck Swearingen said that he had reach out to other county judges and citizens of Lewis County that he was not going to second this motion. Woody Underwood asked Dennis Brown if he is still able to track Portsmouth ambulance runs and he said yes. Woody also said that he would not second this motion. Woody asked Hannah if she would be able to get a total of runs, he explained he would like to see numbers.

Tammy explained if hired as the director she would report budget and financial statements and where the money is being spent. Tammy statement that she would like \$100 per week this cost will be for gas. Tammy said that she would like for all employees that work at the animal shelter to be trained. She feels like that there is lack of training from all areas. Tammy said that she would like to see all animal control officers be vaccinated for rabies. Tammy went on to explain euthanasia was not being done when needed. Dogs were be adopted out that were not spay or neuter. Chuck Swearingen said that he would like to see Tammy present a letter to Fiscal Court before deciding. Rusty Dyer the animal control officer addressed Tammy and said that he has no complains or no issues. He begged the volunteer to put the dog down before going to the vet. Rusty also explains to Tammy that the budget uses of funds fiscal court must approve every year. Every purchase that is made must get through the Judge executive office. That the animal control officer can not get whatever they want. Tammy said management control.
